P1 RESPONSIBILITY

The supplier is responsible to ensure all appropriate requirements are adequately fulfilled, in accordance with the Quote/Purchase Order (contract) requirements and this document. The supplier agrees to obtain Gen-X Machining's written approval before subcontracting this Quote/Purchase Order or any portion thereof.

P2 SCHEDULE

Supplier shall strictly adhere to the shipment or delivery schedule(s) specified in this Quote/Purchase Order. In the event of any anticipated or actual delays including but not limited to delays attributed to Labor disputes Supplier shall promptly notify Gen-X Machining in writing of the reasons for the delay and actions being taken taken to recover and/or minimize the delay including a revised written recovery schedule.

P3 PACKAGING AND SHIPPING

Packaging Method:

Supplier shall ensure product is packaged in accordance with industry standards to prevent damage and deterioration throughout the delivery process.

Shipping Document:

Supplier shall provide shipping documents including a packing slip, applicable certification of conformance, and applicable documentation to support product conformity.

P4 ACCEPTANCE AND REJECTION

- a. If Supplier delivers non conforming Goods, Gen-X Machining may, at its option and at the Supplier's expense, (i) returns Goods for credit/refund, (ii) require Supplier to promptly correct or replace the Goods, (iii) correct the Goods, or (iv) obtain replacement Goods from another Gen-X Machining approved source.
- b. Supplier shall NOT redeliver corrected or rejected Goods without disclosing the former rejection or requirement for correction. Supplier shall disclose any corrective action taken. Redelivery shall be completed within the original delivery schedule or such later time as Gen-X Machining's Buyer may reasonably direct.
- c. All costs and expenses and loss of value incurred as a result of or in connection with nonconformance and repair, replacement or other correction may be recovered from Supplier by equitable price reduction or credit against any amounts that may be owed to the Supplier under this Quote/Purchase Order.

P6 WARRANTY

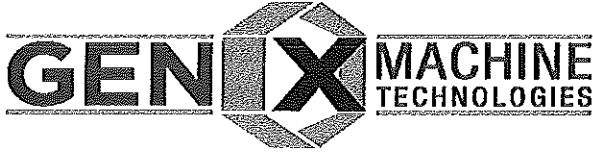
- a. Supplier warrants that all Goods furnished under this Quote/Purchase Order shall conform to all specifications/drawings and requirements of this Quote/Purchase Order and shall be free from defects in material and in workmanship.
- b. Supplier further warrants that it shall NOT furnish "Counterfeit Goods" under this Quote/Purchase Order. "Substitutes" may only be used or provided with the written consent of Gen-X Machining.

P7 TAXES

Unless this Quote/Purchase Order specified otherwise, the price, of this Quote/Purchase Order includes, and the Supplier is liable for and shall pay, all taxes, impositions, charges and exactions imposed on or measured by the Quote/Purchase Order except for applicable sales and use taxes that are separately stated on the Supplier's invoice.

P8 INVOICES AND PAYMENT

Supplier shall issue a separate original invoice for each delivery of Goods that shall include Gen-X Machining's Purchase Order and line item number. Supplier shall forward the invoice(s) to the address specified elsewhere in the Quote/Purchase Order.

P9 FORCE MAJEURE

Supplier shall not be liable for any re-procurement costs due to "Cancellation for Default" of this Quote/Purchase Order, incurred by Gen-X Machining, because of any failure to perform this Quote/Purchase Order under its terms when the causes are beyond reasonable control and without fault or negligence of the Supplier. Examples include, but are not limited to; acts of God or of the public enemy, acts of government, fires, floods, unusually severe weather. In each case, the failure to perform must be beyond the reasonable control and without fault or negligence of the Supplier. Supplier shall notify Gen-X Machining in writing within 10 days after the beginning of any such cause.

P10 RIGHTS OF GEN-X MACHINING TECHNOLOGIES.

Supplier shall comply with all requests for access to Supplier's premises, in relation to this Quote/Purchase Order.

P11 FRAUDELENT/COUNTERFEIT PARTS

Product Traceability - the seller shall be capable of providing full traceability for the product being purchased, including names and addresses of prior sources.
